The Township now live streams Council and Committee of Adjustment meetings. Meetings can be watched in real time from the comfort of home! Archived videos can also be viewed on the Township website.



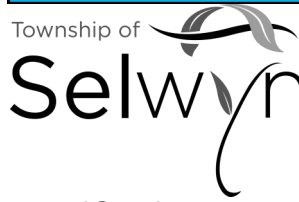
Did you know...

- If you **demolish a structure** you have to **file an application with the Finance Department** in order for your property's current value assessment to reflect the change.
- Any **improvement or addition** to your property will increase the current value assessment. Taxes can be levied on this new value for the **current year and 2 years prior**. Keep this in mind when budgeting after an improvement or an addition.
- The **Municipal Property Assessment Corporation (MPAC)** provides the Township with the assessed value of your property for tax billing purposes. Visit their website for more information: www.mpac.ca
- **Dog Licencing**—all dog owners are required to purchase and keep their dog tags current.

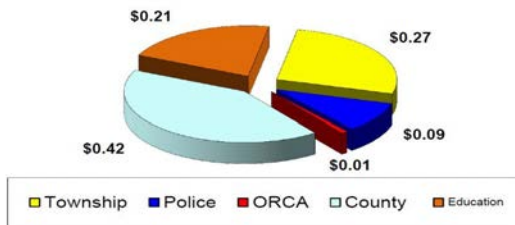
Key Dates

Voting Period: Electors may cast their vote from October 9th, 2018 – October 22nd, 2018 until 8 pm.

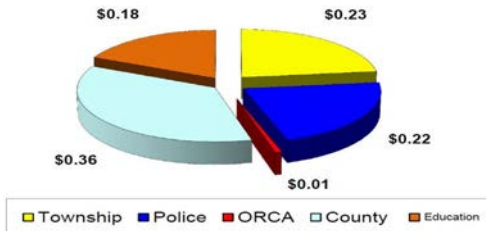
