

Program Description

This program provides a financial incentive in the form of a grant to promote the rehabilitation, restoration and improvement of the front, rear and side facades of commercial, institutional and mixed use¹ buildings, including retail storefront display areas and signage.

Who can apply?

Only owners of properties (and tenants with written authorization from owners) within the Community Improvement Project Area that meet the program eligibility requirements may apply.

The Township retains the right and absolute discretion to reject an application received from a person or corporation which in the opinion of the Township or its professional advisers, does not possess the experience, financial, technical, personnel or other resources that may be required to carry out the obligations that the applicant proposes to assume under the terms of its application and grant agreement.

How does the program work?

The program is structured as a “50-50” grant program where the Township will provide a grant to an applicant equal to 50% of the cost of eligible facade and storefront improvement and restoration works, up to a maximum grant per property/project of \$12,500, excluding HST.

A separate grant of 50% of the cost of eligible side and/or rear facade improvement and restoration works to commercial, institutional and mixed use buildings up to a maximum grant per property/project of \$7,500 (excluding HST) may also be provided where said rear and/or side facades are highly visible from a public road, public parking area or open space.



What types of work are eligible for a grant?

The following types of facade rehabilitation, restoration and improvement works on commercial, institutional and mixed use buildings are considered eligible for a grant under this program:

- a. repair/replacement of storefront, including repair/replacement of storefront doors and windows;
- b. repair or repointing of facade masonry and brickwork;
- c. repair or replacement of cornices, parapets, eaves, soffits and other architectural details;
- d. repair or replacement of awnings or canopies;
- e. facade painting and cleaning/treatments;
- f. addition of new lighting/upgrading of existing fixtures on exterior facade and in entrance and storefront display areas;
- g. installation/improvement of signage (as permitted by the Sign By-law);
- h. architectural/design fees required for eligible works (to a maximum of 10% of the grant amount);
- i. other similar repairs/improvements as may be approved; and,
- j. items a. to i. above as they apply to eligible side facades and rear facades.

¹ Mixed use includes commercial/residential, commercial/institutional and other mixed uses containing commercial use.



What conditions must be met to be eligible for a grant?

In addition to the General Program Requirements, the following program specific requirements must also be met:

- a. Eligible works must conform to the Township’s Village and Hamlet Core Design Guidelines, and appropriate reference material as determined by Township staff;
- b. For buildings designated under the *Ontario Heritage Act*, the facade restoration and improvement works should be supported by documentation in the form of historic photographs or drawings clearly showing the feature(s) to be restored or reconstructed;
- c. The applicant will be required to submit at least two (2) cost estimates from bona fide licensed contractors, including a detailed breakdown of costs;
- d. Construction of all proposed improvements is to be completed within one year of the date of the approval of the grant. If the work is not completed within one (1) year, the grant approval will cease and the grant will not be paid.

Is there a fee to apply?

No.

When will the grant funds be advanced?

The grant will be advanced when:

- a. a Grant Agreement has been signed and executed;
- b. construction is complete;

- c. the building has been inspected by municipal staff; and,
- d. the applicant provides proof that all contractors have been paid.

What are the default provisions?

The default provisions are contained in the Grant Agreement. Payment of the grant may be cancelled if:

- a. property taxes are more than three (3) months in arrears;
- b. the building is demolished or any of the heritage features are altered in any way that would compromise the reason for designation;
- c. the applicant declares bankruptcy;
- d. the applicant uses the grant for works that are not eligible for this program;
- e. the applicant fails to maintain the improvements as required in the Grant Agreement; and,
- f. the applicant is in default of any of the provisions of the Grant Agreement.

How do I apply for a grant?

Arrange a pre-application meeting with staff in order to determine program eligibility, proposed scope of work, project timing, etc.

If authorized to apply for a grant, complete and submit an application form. Ensure that all required signatures have been provided and that the application is accompanied by all required documentation as shown in the required documents checklist.



What happens next?

Applications and supporting documentation are reviewed by staff to ensure that they meet all of the eligibility requirements. If your application does not meet the eligibility requirements, you will be notified of this in writing.

- a. Staff may request clarification or additional supporting documentation.
- b. Staff will perform an initial site visit(s) and inspection(s) of the property (if necessary).
- c. A recommendation on the grant application will be made by staff and forwarded to Council or Council's designate.
- d. If staff is recommending approval of your application, you will be provided with a Grant Agreement for your acceptance.
- e. If your application is approved by Council or Council's designate, the Grant Agreement is then executed by you and the Township. A copy of the executed agreement(s) is then returned to you for your records.
- f. Construction of the approved works may now commence, subject to issuance of a permit(s) (as applicable).
- g. Upon completion of the works, staff will conduct a final site visit(s) and inspection(s) (as necessary) to ensure compliance with the Grant Agreement, Village and Hamlet Core Design Guidelines and any permits pursuant to the *Ontario Heritage Act* and other Acts.
- h. Submit to the Township, copies of paid invoices and "before and after" picture(s) of the completed works.
- i. Upon review and approval of all submitted documentation, the Township will issue a grant cheque to the applicant for the amount of the approved funding.
- j. The actual grant amount will be calculated based on 50% of the original cost estimate for the works or 50% of the actual cost of the works, whichever is less.

- k. The applicant will be asked to complete a grant receipt form and return this to the Township.
- l. The Township reserves the right to audit the cost of the works prior to advancing the grant payment.
