

**Corporation of the
Township of Selwyn**

By-Law Number 2023 - 041

**Being a By-law to Amend By-law # 81-7 of the Former Village of Lakefield,
a By-law to Regulate, Supply and Prohibit the Wrongful Use of the
Lakefield Water Supply System.**

Whereas the Ontario Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides that the Council of a local municipality may by By-law prescribe and charge rates for certain services;

And Whereas the former Council of the Corporation of the Village of Lakefield approved By-law # 81-7 to regulate the supply of water and impose water rates within the Lakefield water service area;

And Whereas the Council of the Corporation of Township of Selwyn received and approved the 2023 budget for water services in the Lakefield water service area including estimates for increased operating expenses and additional costs in support of an ongoing review of systems, plans and related legislation;

And Whereas in support of the approved budget and long term capital planning for the water utility, Council deems it desirous and proper to amend the water rates with a rate increase of one percent (1%);

Now Therefore the Council of the Corporation of the Township of Selwyn
Enacts As Follows:

1. That Village of Lakefield By-law # 81-7 is amended by replacing the Schedule "A" attached thereto with the Schedule "A" attached to this By-law.
2. That the Township of Selwyn By-law 2022-039 is repealed in its entirety following the implementation of Schedule "A" attached to this By-law.
3. That all other sections of Village of Lakefield By-law # 81-7 shall remain in full force and effect.
4. That this By-law shall come into force and effect upon passage such that the rates shall be effective with the July 2023 billing cycle.

Read a first, second and third time and finally passed this 6th day of June, A.D., 2023.

Sale Of Water From Fire Hydrants

For any Township of Selwyn ratepayer or contractor performing work for the Township municipal operations that wishes to purchase water, the following charges apply:

A flat rate charge of \$86.04 and \$9.82 per 1000 gallons (4.55m³) or part thereof
(Such water purchase shall be subject to Township permission and discretion.)
