BY-LAW NUMBER 2008-010

BEING A BY-LAW TO AMEND BY-LAW 2004-24, A BY-LAW TO EXEMPT CERTAIN RETAIL ESTABLISHMENTS LOCATED IN THE TOWNSHIP OF SMITH-ENNISMORE-LAKEFIELD FROM THE PROVISIONS OF THE RETAIL BUSINESS HOLIDAYS ACT PURSUANT TO THE TOURISM CRITERIA.

WHEREAS the Retail Business Holidays Act, R.S.O., 1990 c. R.30, Section 4 (1) as amended, states that a municipality may by By-law permit retail business establishments in the municipality to be open on holidays for the maintenance or development of tourism; and

WHEREAS the Council of the Township of Smith-Ennismore-Lakefield passed By-law 2004-24 on the 23rd day of March, A.D., 2004, to exempt certain retail establishments from the provisions of the Retail Business Holidays Act pursuant to the tourism criteria; and

WHEREAS the Council of the Township of Smith-Ennismore-Lakefield deems it necessary to amend By-law 2004-24, by amending Schedule "A" forming part of this By-law, to allow various businesses to remain open on certain statutory holidays;

WHEREAS the Council of the Township of Smith-Ennismore-Lakefield is satisfied that those businesses comply with the Tourism Criteria pursuant to O. Reg. 711/91 and deems it essential that these businesses be exempt from the provisions of the Retail Business Holidays Act, R.S.O., 1990 c. R.30, as amended, for the maintenance or development of tourism;

NOW THEREFORE, the Council of the Corporation of Smith-Ennismore-Lakefield **HEREBY ENACTS AS FOLLOWS**:

1. That Schedule "A" be amended by adding the following:
