1. Drinking Water Supply

The Woodland Acres water distribution system obtains its water from the City of Peterborough's municipal water system. This system is operated under contract by PUG Service Corp. 2. <u>Water Pumping Stations</u>

There is a water booster pumping station at Woodland Drive and Woodward Avenue.

3. Water Distribution Piping System

The water distribution system consists of approximately 4,651 meters of pipe (water mains), 26 hydrants and 334 individual water services. In 2021 The Township assumed water infrastructure for the Summerlane Subdivision.


