Property Tax due dates

Did you know that tax payments are always due the 1st Monday of **March, May, and October** and the 2nd Monday in **August**? Activate your VTH account to enroll in electronic billings and make debit card payments online.

Property Tax Pre-Authorized Payments (PAP)

We now offer 3 monthly pre-authorized payment plan (PAP) options as well as our installment plan. All 3 monthly plans run from February - November, with no withdrawal in January or December. See enclosed insert for more details.

Are you already on PAP? Your payment amounts are now printed on your tax notices. Want to change your plan type? Do it yourself through your VTH account or use the Selwyn Township App or our website to submit the request: selwyntownship.ca/PaymentOptions

Curbside and Landfill site: Clear Bag Program

Start using clear bags - as of September 1, 2021 they will be mandatory both for curbside collection and at the landfill site. See your enclosed blue landfill site pass, the Selwyn Township App or our website for more information.

CIP updates: COVID-19

In response to the impacts of COVID-19, two temporary changes have been made to our original Community Improvement Plan (CIP):

1. The cost sharing formula has been increased to 70% Township : 30% applicant; (from 50% each)
2. Introduction of the COVID-19 Pilot Grant Program

These changes expire December 31, 2022.
