Tax Relief for Low Income Seniors and Persons with Disabilities

If you receive the Guaranteed Income Supplement (GIS) or a payment under the Ontario Disability Support Program (ODSP) Act, you may be eligible for tax relief equal to the amount your property taxes increased between 2022 and 2023, to a maximum of \$200.00. For full details, visit:

Leaf & Yard Waste Fees (for loads greater than 100 kg)	\$85/tonne	\$100/tonne

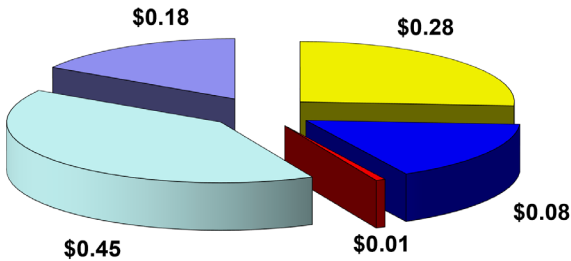
2023 Final Installment Due Dates

2023 Distribution of Residential Tax Dollar

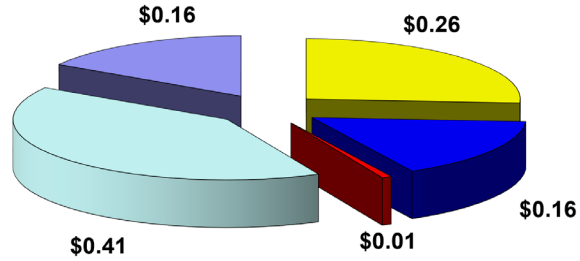
Rural Ratepayer:

Online Tax Tools

There's so much available at your fingertips with Virtual Town Hall (VTH):

- Enroll in paperless notifications
- Update your email/ mailing address
- Start, change or stop pre-authorized property tax payments
- Pay property taxes, receivables and animal licences
- View transaction and assessment history for your property tax account

Payment Information

Property taxes can be paid by:

- Pre-authorized payment (PAP)
- Online/telephone banking
- VTH (limited to those banks participating in Interac Online)
- Cash, debit and cheque (including post-dated)

Payments are due by the installment due dates, after that date and the beginning of each following month, penalty/interest is applied at a rate of 1.25% per month.
