

#### Q3 Who completed the application?





# Q4 How would you rate your understanding of the planning review process (e.g. the Township Official Plan, Zoning By-law and other relevant policy or legislation)?













# Q11 Did you have a pre-consultation meeting with staff and relevant agencies at the start of your project to explain your project and understand what was required?





### Q12 Was this meeting helpful?




