Notice of a Complete Application and Public Meeting Concerning a Proposed Zoning By-law Amendment (REVISED)

Take notice that the Corporation of the Township of Selwyn is in receipt of a complete application to amend Zoning By-law No. 2009-021, as amended, for certain lands described as being Part Lot 37, Concession 12 in the Smith Ward having the municipal address of 2090 Nathaway Drive.

Take notice that the Corporation of the Township of Selwyn will hold a Public Meeting on **Tuesday, September 26, 2023 at 1:30 p.m.** to consider the proposed Zoning By-law Amendment under Section 34 of the *Planning Act*, R.S.O., 1990, as amended.

Participation in the Public Hearing

Virtual

Any person may attend the virtual public hearing and make written and/or oral submissions either in support or opposition to the proposal. In order to make arrangements to attend the virtual hearing please contact the Clerk by email at achittick@selwyntownship.ca no later than 4:00 p.m. on the day **prior** to the scheduled public meeting. You will be given guidance and instructions on how to attend via Zoom. It is the responsibility of those interested in attending to have the technology in place to connect to the hearing.

Location

The key map below indicates the location of the lands which are subject to this application. The subject property is legally described as Part of Lot 37, Concession 12 (Smith) having the municipal address of 2090 Nathaway Drive.

The Zoning By-law Amendment

The site is currently zoned **Local Commercial (C2) Zone** and **Environmental Protection (EP) Zone** and is the site of a model home and former house sales centre. The current owner has applied to the Township of Selwyn to re-zone the subject property to the **Residential Type (R1) Zone** in order to permit the model home and former sales centre to be used as a residential dwelling. To retain the possibility for a future commercial use at this property, the Township will re-zone the subject lands to a **(C2) special exception zone** to permit both (C2) commercial uses and (R1) residential uses. The Environmental Protection (EP) Zone will remain unchanged.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Selwyn to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of

Selwyn before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Selwyn before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
