Notice of a Complete Application and Public Meeting Concerning a Proposed Zoning By-law Amendment (REVISED)

**Take notice** that the Corporation of the Township of Selwyn is in receipt of a complete application to amend Zoning By-law No. 2009-021, as amended, for certain lands described as being Part Lot 12, Concession 4 (Ennismore) having the municipal address of 899 Settler's Trail.

**Take notice** that the Corporation of the Township of Selwyn will hold a Public Meeting on <u>Tuesday, October 24<sup>th</sup>, 2023 at 1:30 p.m.</u> to consider the proposed Zoning By-law Amendment under Section 34 of the *Planning Act,* R.S.O., 1990, as amended.

## Participation in the Public Hearing

## Virtual

Any person may attend the virtual public meeting and make written and/or oral submissions either in support or opposition to the proposal. In order to make arrangements to attend the virtual meeting please contact the Clerk by email at <u>achittick@selwyntownship.ca</u> no later than 4:00 p.m. on the day **prior** to the scheduled public meeting. You will be given guidance and instructions on how to attend via Zoom. It is the responsibility of those interested in attending to have the technology in place to connect to the meeting.

## Location

The key map below indicates the location of the lands which are subject to this application. The subject property is legally described as Part Lot 12, Concession 4 (Ennismore) having the municipal address of 899 Settler's Trail.

## The Zoning By-law Amendment

The County of Peterborough has granted provisional approval for a new lot through County Land Division File No. B-62-23. The subject lands will be re-zoned from the Lakeshore Residential (LR) Zone to the Lakeshore Residential Exception 602 (LR-602) and Rural Residential Exception 603 (RR-603) Zone to permit reduced lot area and frontage requirements for the proposed severed and retained parcels, as needed. The (LR) and (RR) zones require 4050 m<sup>2</sup> of lot area and 45 metres frontage. The proposed severed parcel will be  $\pm 2352 \text{ m}^2$  with  $\pm 37 \text{ m}^2$  of frontage on Skyline Road. The proposed retained parcel will be  $\pm 4059 \text{ m}^2$  with  $\pm 18$  metres of frontage on Settlers Trail. Reduced side yard setbacks to 3 meters for the severed parcel will also be addressed through the zoning amendment.

**If a person or public body** would otherwise have an ability to appeal the decision of the Council of the Township of Selwyn to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of

Selwyn before the by-law is passed, the person or public body is not entitled to appeal the decision.

**If a person or public body** does not make oral submissions at a public meeting or make written submissions to the Township of Selwyn before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
